11/32" spacing between horizontal lines, with a vertical 1¼" margin on the left-hand side. Commonly used by those with larger handwriting.



Legal Rule

11/22* spacing between ruling lines. Standard for legal applications. Law Ruling is Legal Rule with a 3" margin.



College or Medium Rule 1/12" spacing

between lines.



Narrow Rule

1/4" spacing between lines.



Quadrille Rule Horizontal and vertical lines evenly spaced over the entire page, creating a grid of squares.

Litigation Rule Unique format with two sections, each with a smaller left margin for concise note taking.
