

# BUYING GUIDE • Notepad Rulings



**Wide Rule**  
1/2" spacing between horizontal lines, with a vertical 1/4" margin on the left-hand side. Commonly used by those with larger handwriting.



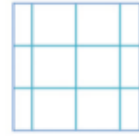
**Legal Rule**  
1/2" spacing between ruling lines. Standard for legal applications. **Law Ruling is Legal Rule with a 3" margin.**



**College or Medium Rule**  
1/2" spacing between lines.



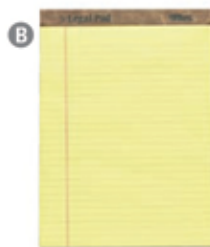
**Narrow Rule**  
1/4" spacing between lines.



**Quadrille Rule** Horizontal and vertical lines evenly spaced over the entire page, creating a grid of squares.



**Litigation Rule** Unique format with two sections, each with a smaller left margin for concise note taking.
